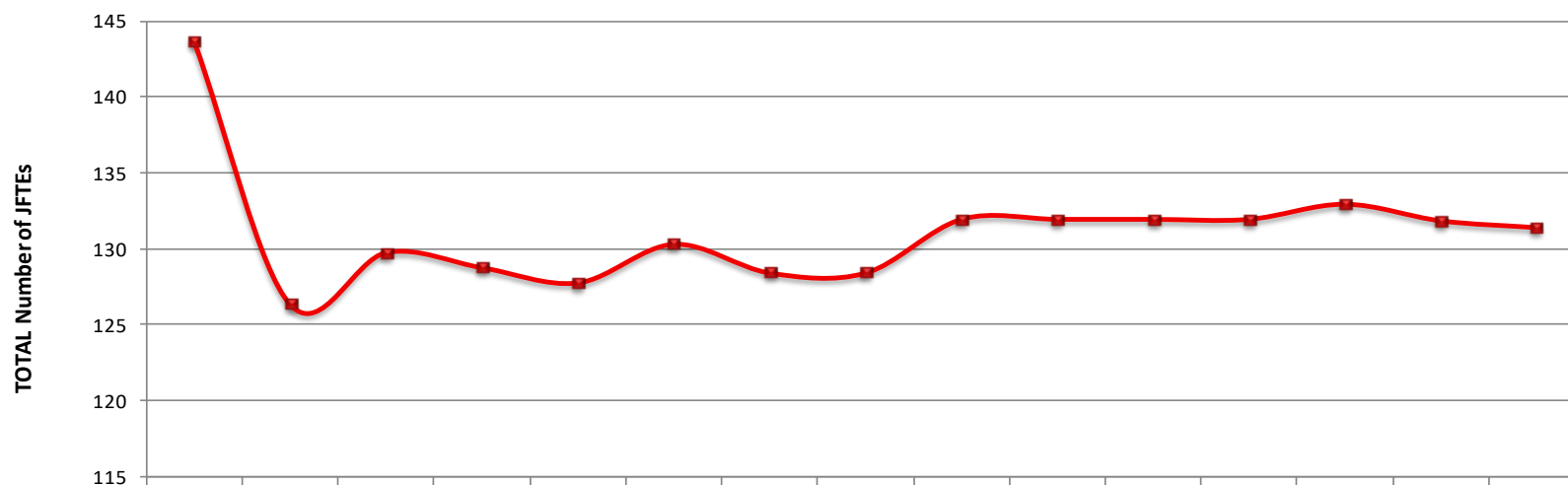

ⁱ The complement number shown here reflects the JFTE as of the first day of the next month. The retirement of a judge, election of a judge to senior status, or the return of a judge previously on LTD to sitting status on the first day of a month is recorded as of the last day of the previous month. The last sitting day of a retiring senior judge is recorded as a retirement as of the last day of the month in which that occurred.

ⁱⁱ JFTE = Judicial Full Time Equivalent positions. This includes all full time judge positions (1 JFTE) + all senior judge positions (0.45 JFTE) province wide. This total does not include the equivalent of 4.40 FTEs currently on full or partial Long Term Disability.
